



**Contest Rules for Best Buy Canada Ltd. (“Best Buy”)

How to Enter

1. No purchase necessary.
2. Entries may be made between 9:00 a.m. PST on November 3, 2017 and 11:59 p.m. PST on November 16, 2017 (the “Contest Period”) in one of the following methods:
 - a. Online: Tell us one thing on the Holiday Gift Guide that you would like to receive or to give this holiday season.
 - b. By Mail: Print your full legal name, date of birth, city or town of residence, phone number, email address and tell us one thing on the Holiday Gift Guide that you would like to receive or to give this holiday season on a 3” by 5” piece of paper, and mail it to: “HOLIDAY TOY CONTEST 2017” 8800 Glenlyon Parkway, Burnaby, BC, V5J 5K3.
3. One entry per person maximum. Participants making more than one entry may be disqualified. Entries that are fraudulent are not permitted and will be declared invalid.

Who Can Enter

11. Following the draws, the selected entrants will be contacted in an email response to their contest entry.
12. In order to receive a prize, the selected entrants must:
 - a. respond to the prize notification email within forty-eight (48) hours of transmission;
 - b. correctly answer, unaided, a time-limited, mathematical skill-testing question; and
