

## Win Big with HP & Real Madrid Contest Official Rules

## No Purchase Necessary to Enter or Win. A Purchase will Not Increase Your Chances of Winning.

**Eligibility:** The Contest is open to legal permanent residents of Canada (excluding the Province of Quebec) who have reached the legal age of majority in their province/territory of residence (which is eighteen (18) in most provinces, but is nineteen (19) in certain Canadian provinces/territories) as of the date of entry. Employees, officers, directors, agents and representatives of HP Canada Co. ("Sponsor"), teamDigital Promotions, Inc. ("Administrator"), Toronto Fashion Academy, Best Buy Canada Ltd. All entries must be received by 11:59:59 pm ET on 9/25/24 to be eligible. Limit one (1) entry per person, per email address throughout the Promotion Period, regardless of the method of entry. You may only use one (1) email address to enter the Contest. Entries received from any person, email address, or household in excess of the above stated limitation will be void. Your submission of an entry constitutes your consent to participate in this Contest and your consent for Sponsor and Best Buy to obtain, use and transfer your name, address and other information for the purpose of administering this Contest.
